Percentage Bequest

A percentage bequest allows you to leave a specified portion of your estate or assets to Animals First Aid. For example, you could choose to have your home sold upon your passing, with each of your three children receiving one-third of the net proceeds. You can designate any percentage, from 1% to 100%, to be left to Animals First Aid. This approach ensures that as your estate grows over time, so does your impactful support for our mission to help animals in need.

RESIDUARY BEQUEST

Residue is the term used to describe the portion of an estate that remains after all debts, expenses, and specific bequests to others have been fulfilled.
